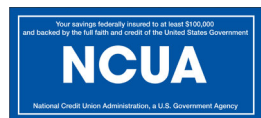

## ATM Card Disclosure

- ATM Cards will be ordered and mailed to the member at the address we have in our system.
- You may have an ATM Card with a savings account, checking account, or ATM/direct deposit account. If you have a debit card with your checking account you can NOT receive an ATM Card also.
- You will receive the PIN number in the mail within 7-10 days with the ATM Card following within about 3 days.
- To activate your ATM Card you will now be required to use the card at any terminal with the PIN number. You must use the PIN provided with that card!
- Cash withdrawals from ATM machines are limited to \$500.00 within a 24 hour period.
- Point of Sale purchases (pinned transactions) may be made only from a checking or ATM/direct deposit account and are limited to the balance in the account and are debited immediately.
- If you abuse the privilege, such as improper use or repeated loss of your card, your right to have a card may be denied.
- If your card is lost or stolen you must fill out a replacement application for a new card and a fee of \$5.00 will be charged.
- **Your card must be used at least once every 6 months to keep it active. If not, the card will be flagged inactive and a replacement application must be filled out and a fee of \$5.00 will be charged.**
- **To report a card lost, please call TVR at 601-984-1315 and follow the prompts to cancel the card . If the card is lost during business hours you may contact the Credit Union at 601-984-1315 and press 0.**
